Food Vendor Application, Rules and Information

Thank you for your interest in the Orange Blossom Jamboree, a celebration of Florida's homegrown music and arts. We have chosen a beautiful venue to host our event centrally located within the state, just outside of Tampa. We are expecting anywhere between 800 and 1,500 guests to join in on the festivities. This is a family friendly event so we encourage treats for the kids too. We want all of our vendors to be successful; therefore, we are limiting our vendors as follows:

2 main food vendors (full menu)	\$450 fee
3-5 specialty/desert vendors (booth or push cart)	\$250 fee

We will do our best to ensure that we do not duplicate any services of the vendors chosen.

The vendor fee is good for a staff of 2 persons. If additional staff is needed, each person must pay an additional \$30 (ticket price). Additional primitive camping is available to them at that price.

Each food vendor will be provided an RV size campsite equipped with water and electric hookup. The designated vendor site will also be your campsite.

We will notify the selected vendors by February 15, 2010. Upon notification of acceptance we will require payment for your space in full by March 1, 2010 along with a copy of your insurance, license and signed contract. If you are unable to meet the deadline your space will be reassigned to another vendor. Once accepted and payment is made no refunds will be available unless the event is 100% cancelled.

Vendors will be required to arrive to the festival grounds for setup on Friday, May 21, 2010 before 12pm and be open for business by 5pm and remain open until 10pm at the minimum. Saturday, vendors must be open for business from noon until 10pm or later. Vendors may stay and vend on Sunday but it is not required.

We require that all participating food vendors present themselves and their setup in a professional manor at all times, keeping the area clean and safe for our guests. Vendors are required to dispose of all waste and recyclable materials properly in designated areas.

Food Vendors are required to carry liability insurance of \$1,000,000 per event and have Sertoma Youth Ranch and Orange Blossom Jamboree named as additional insured. This must be provided at time of acceptance/payment.

Vendor acknowledges and agrees that Orange Blossom Jamboree, LLC does not guarantee weather conditions or guest numbers and shall not be liable for loss or damages of any type due to partial or complete cancellation of the event. OBJ, LLC is in no way responsible for merchandise or equipment damage, personal injury or property damage at the event. Vendor agrees to comply with requirements listed within this application.
